

## **INSTRUCTIONS**

- FERTILGOLD®\* POWDER should be applied when tissue and soil analysis identifies the need and proper rate of application for this product.
- Best results will be obtained when application is concentrated in the active root zone.
- Can be applied in combination with compatible plant growth regulators, pesticides, or other granular fertilizers except urea.
- Apply FERTILGOLD® POWDER by broadcast, using airplane or ground machines.
- FERTILGOLD® POWDER can be applied to all soil types for agriculture fields, ornamentals, lawns, gardens, and landscapes.
- Application timing, intervals, and rates may vary according to individual crop requirement, stage of development, available nutrient levels in the soil, and overall nutritional status of the crop.
- Soil moisture is required for maximum bioactivity. If soil is dry, moisture should be provided by irrigation.
